## **Business Office Report Submitted to PARISH COUNCIL**

Activities for  
July, 2008:

Included in this packet is the July, 2008 financial report. The checking accounts, D& L savings accounts were reconciled. The Archdiocese of Dubuque and Endowment fund statements will be reconciled upon receipt of statements. The parish income and expenses reflected net income of \$48,847 for July, the first month in the new fiscal year. Prepayments of tuition was the major contributing factor for the positive balance.

- At the end of July the savings balance was \$411,824 and the building loan balance was \$662,000, a loan reduction of \$18,000 for July.
- The Development Commission prepared a Building Fund Update which was mailed to all parishioners and was also distributed as a bulletin insert. Our goal is to pay off our building fund loan by December 31, 2008.

Activities for August, 2008:

- School has started... The new computers and TV screen were installed... Kudos to Rick Hoening for all of his leadership and time spent in installation of the new technology. The custodial staff is also to be commended for their work in preparing the education center for the new school year.
- Personnel change: Michael Keller, a recent hire as full time custodian for education center, left our employment. Donald Hahn was hired as his replacement. Don started August 19<sup>th</sup>.
- We are still working on the parish year end Archdiocesan report. Should be completed and submitted in the next two weeks.
