Computers, cameras, printer and software have been purchased with it but there is not enough remaining to cover the cost for a lighting system needed for taking the ID photos and for the \$1,500 training cost (Nancy is taking part in the training) and other miscellaneous startup expenses. Nancy asked SJ for a donation of \$500
- f. Harvest of Blessings Allocation Doreen reported for Julie Haas. The \$500 set aside for Harvest of Blessings is not needed. Consensus of SJ members is that the \$500 be given to the Community ID Program as requested by Nancy Heideman
